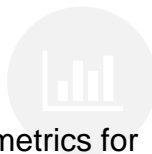

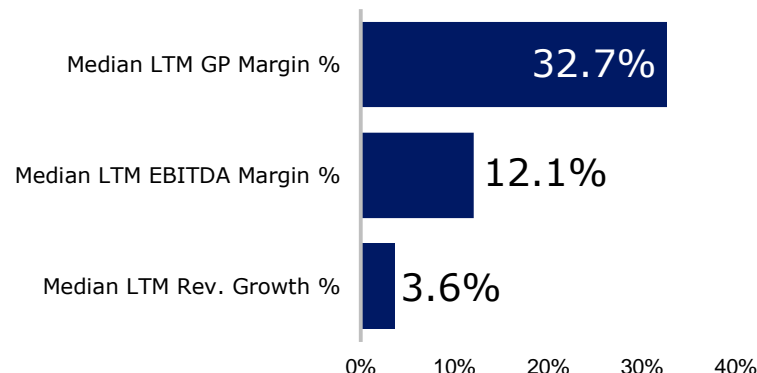

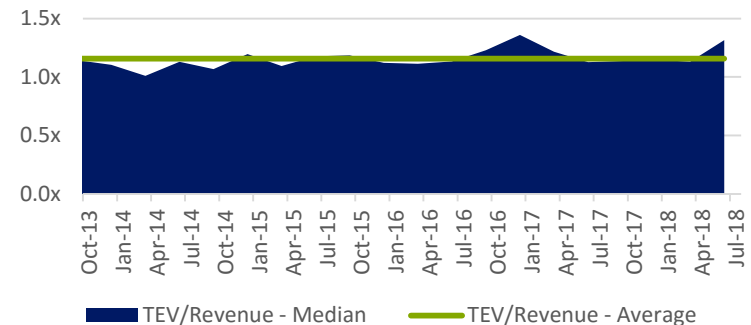

Public Revenue Multiples over Time



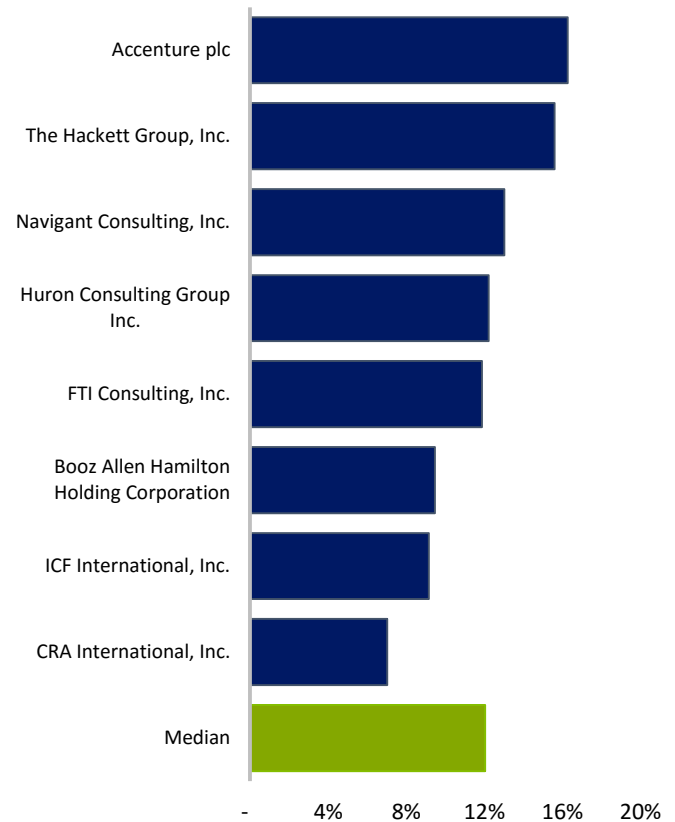

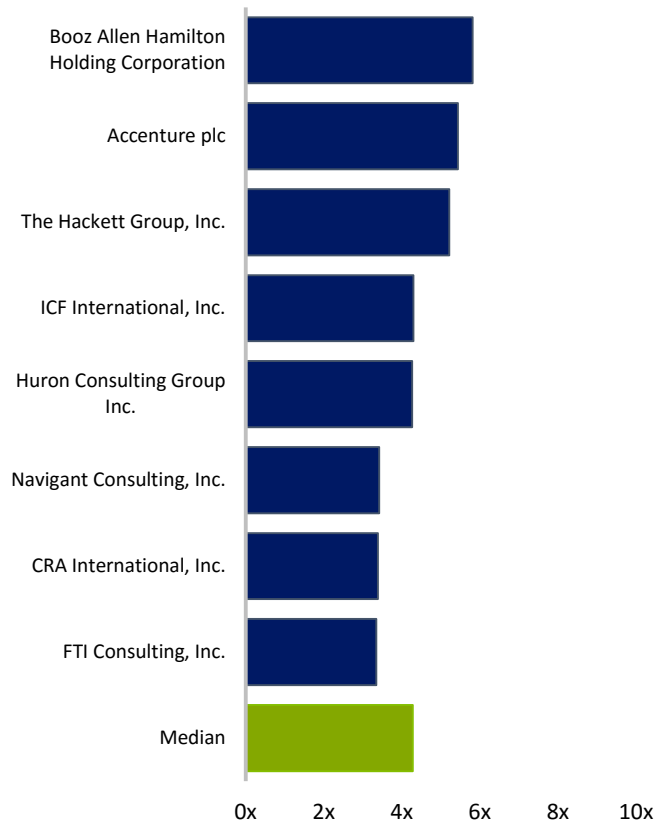

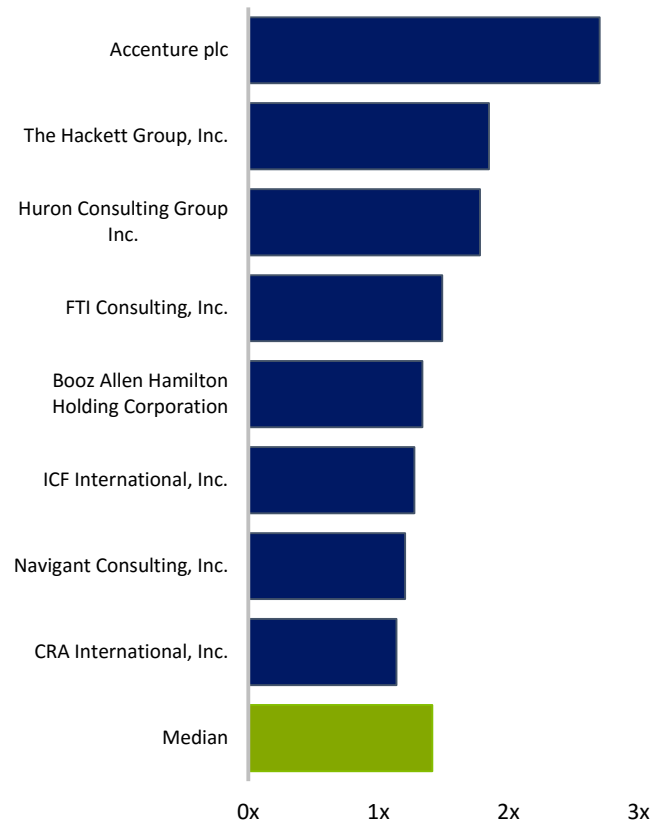

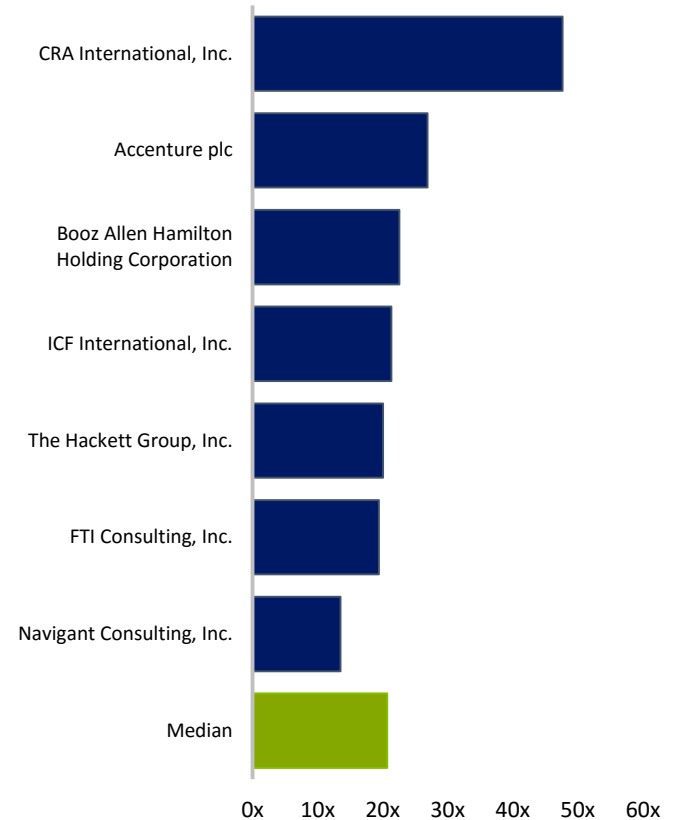

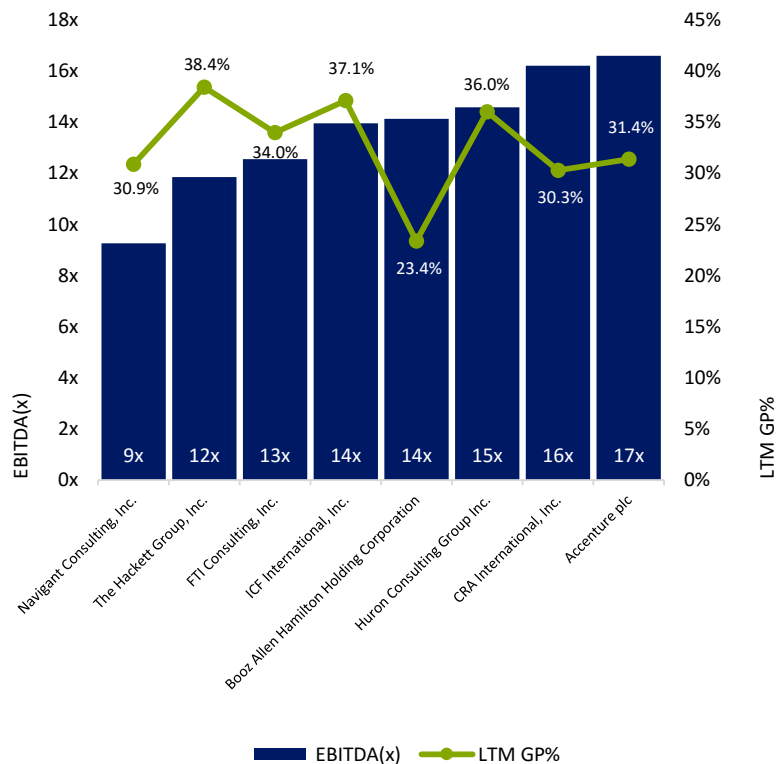

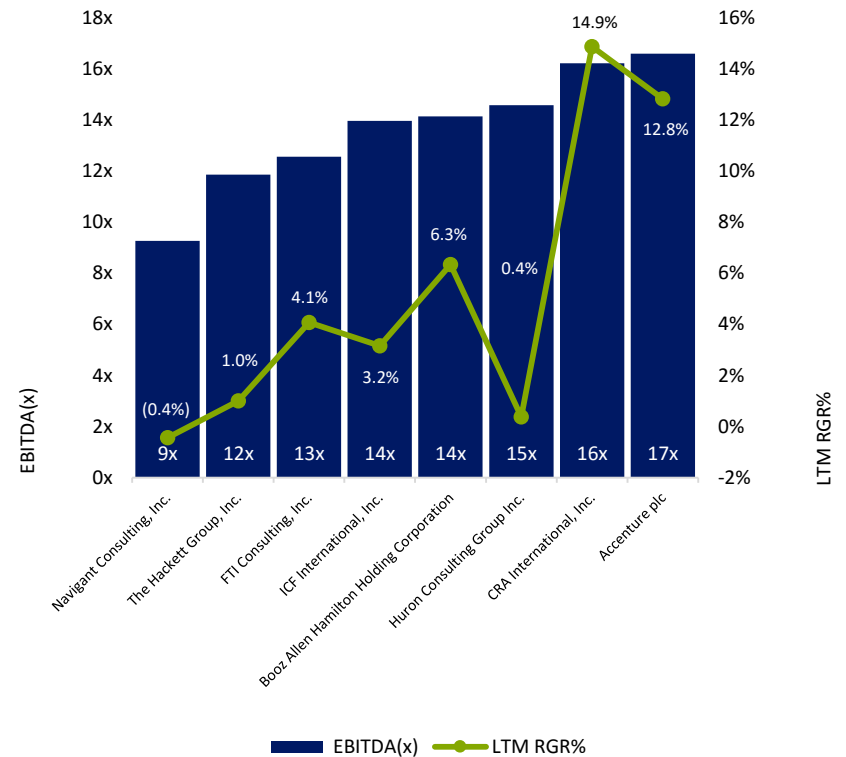

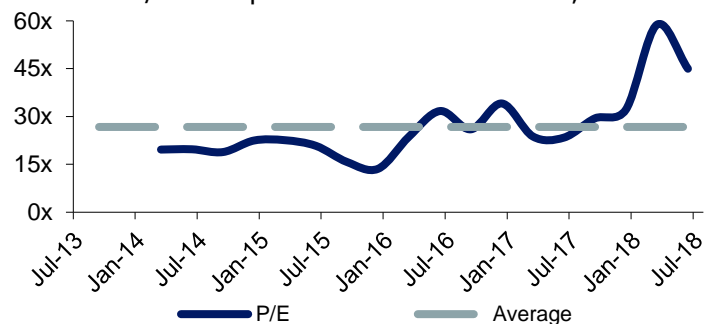
Revenue Multiples - CRA International, Inc.

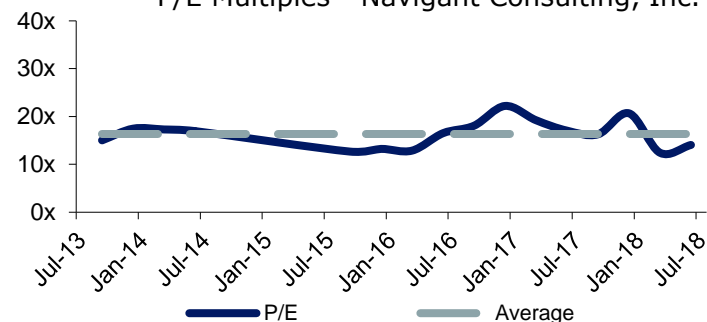
Revenue Multiples - Navigant Consulting, Inc.

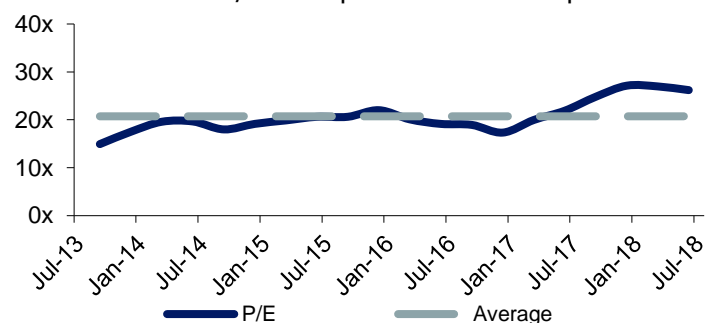
Revenue Multiples - Accenture plc
