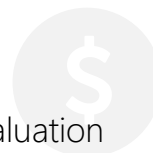

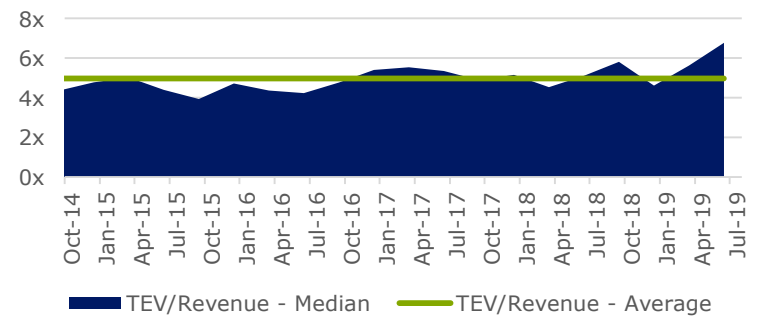

## Public EBITDA Multiples over Time



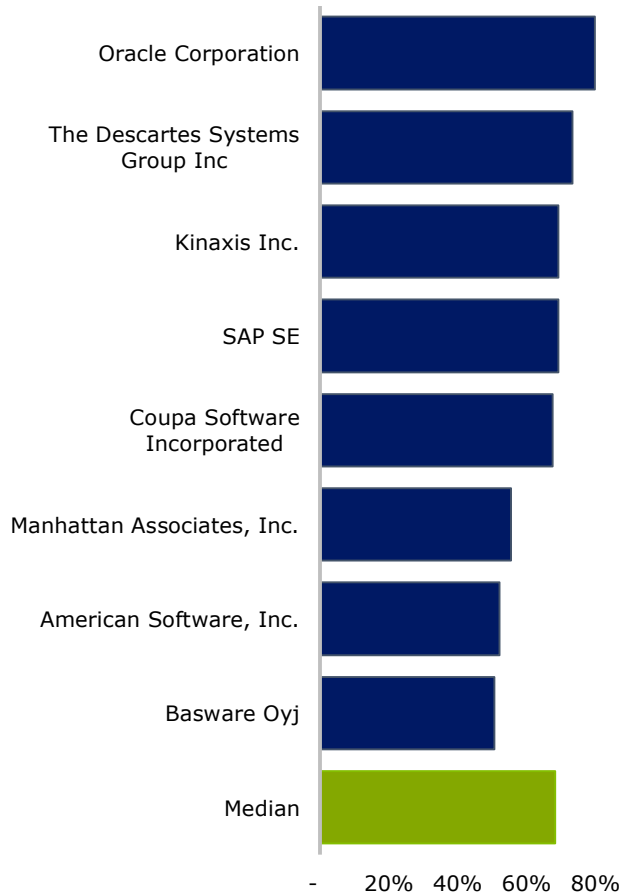
## Public Revenue Multiples over Time



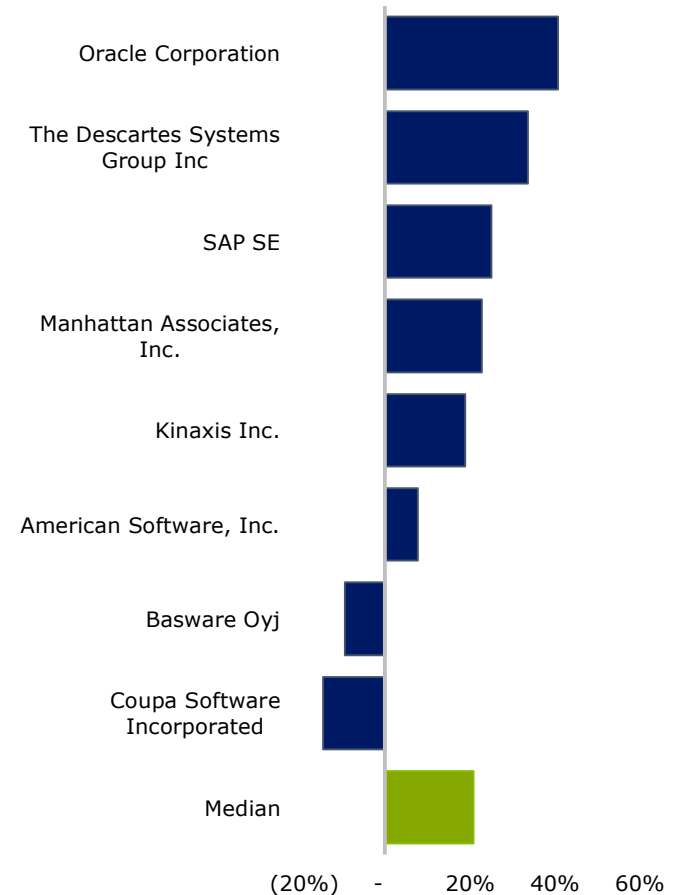

LTM Gross Profit Margin %



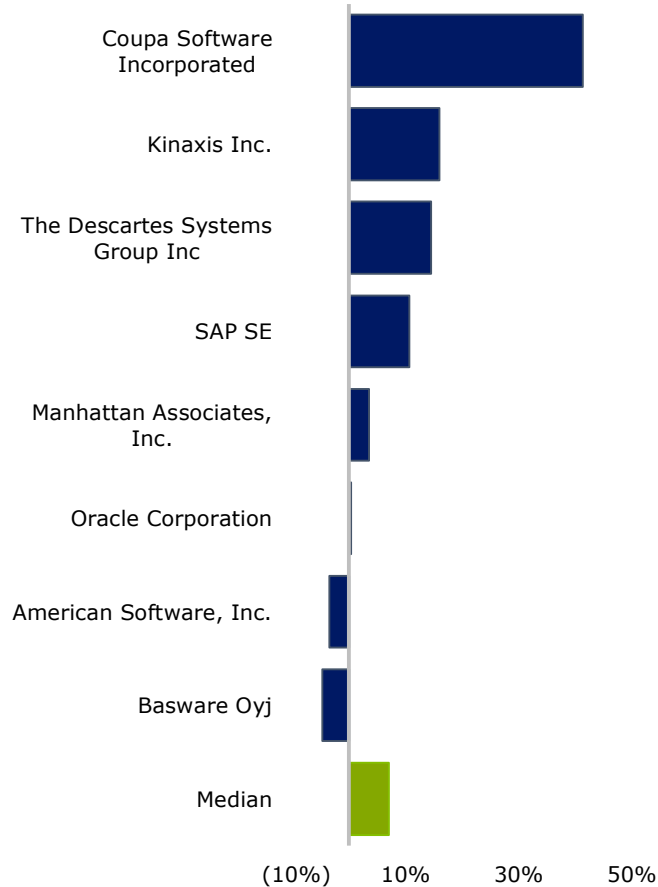

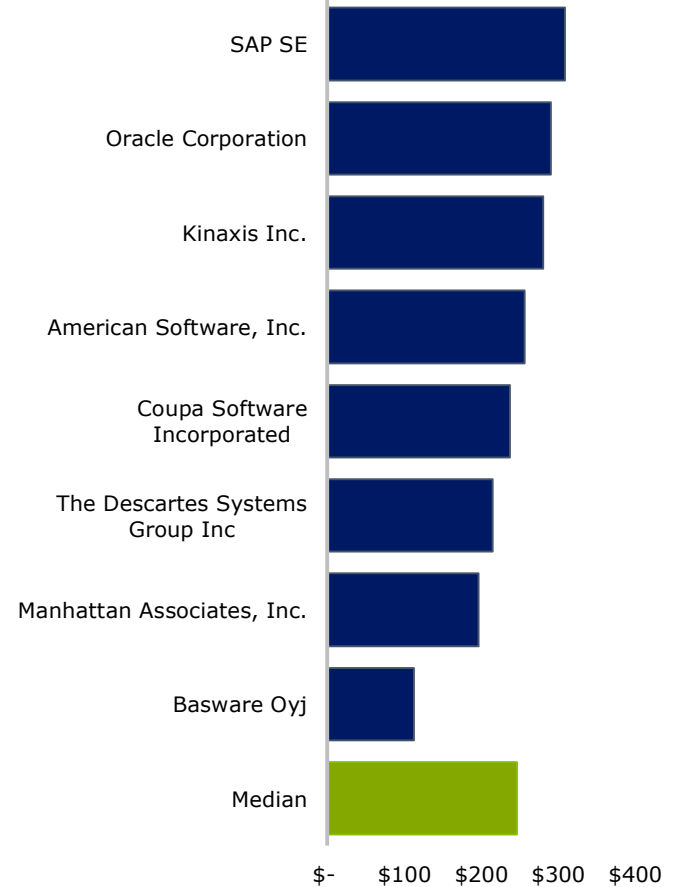

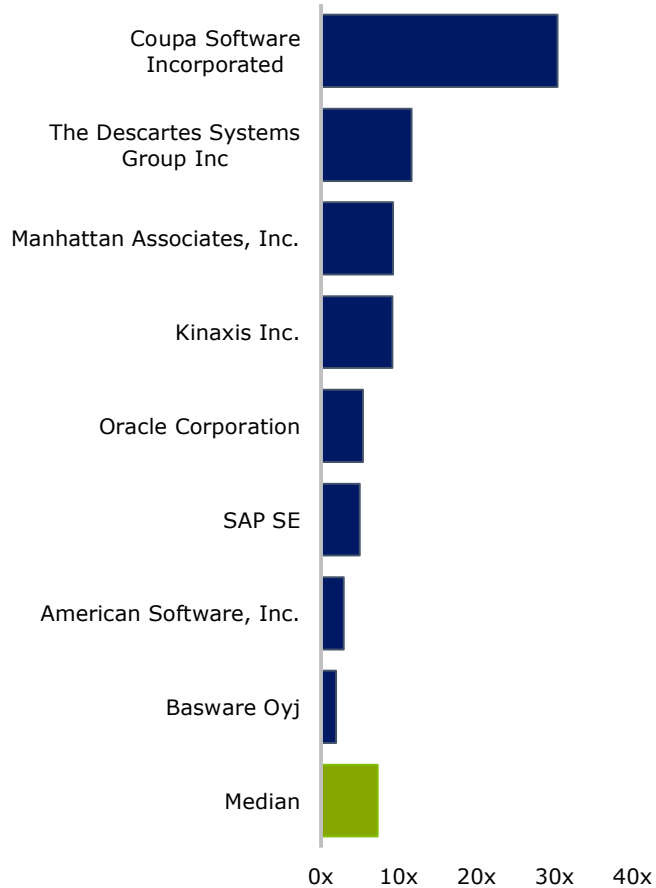

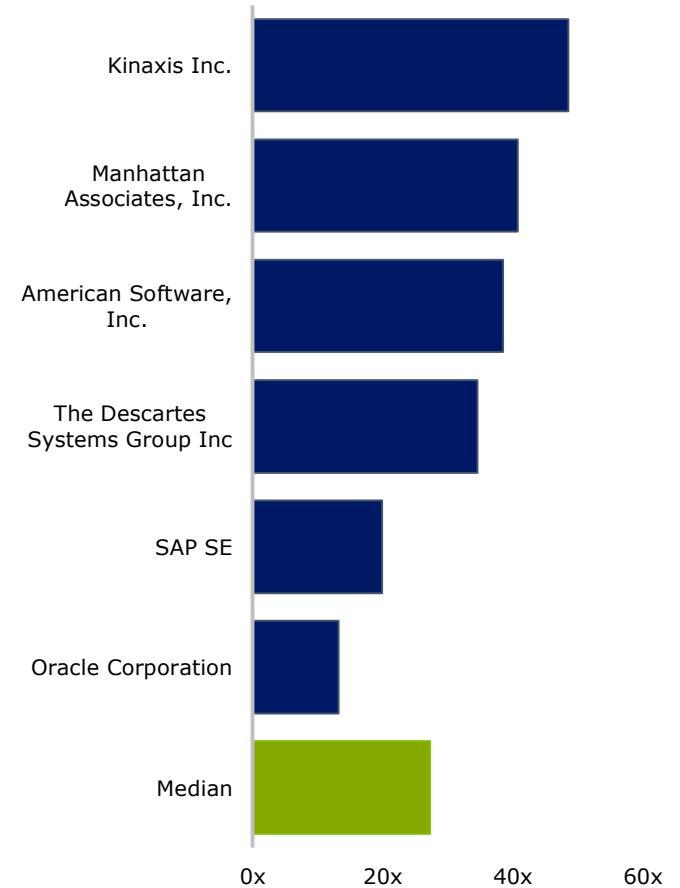

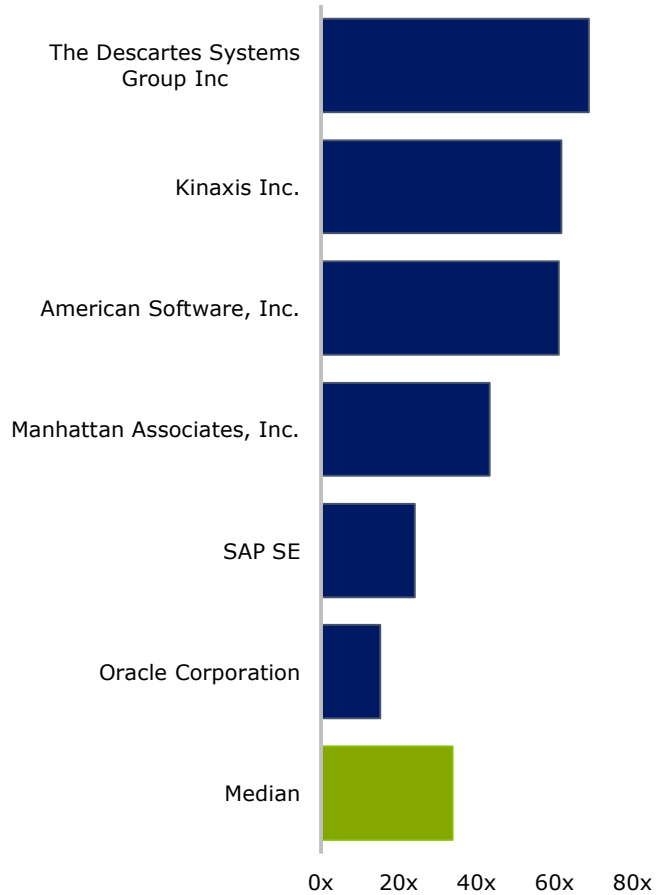

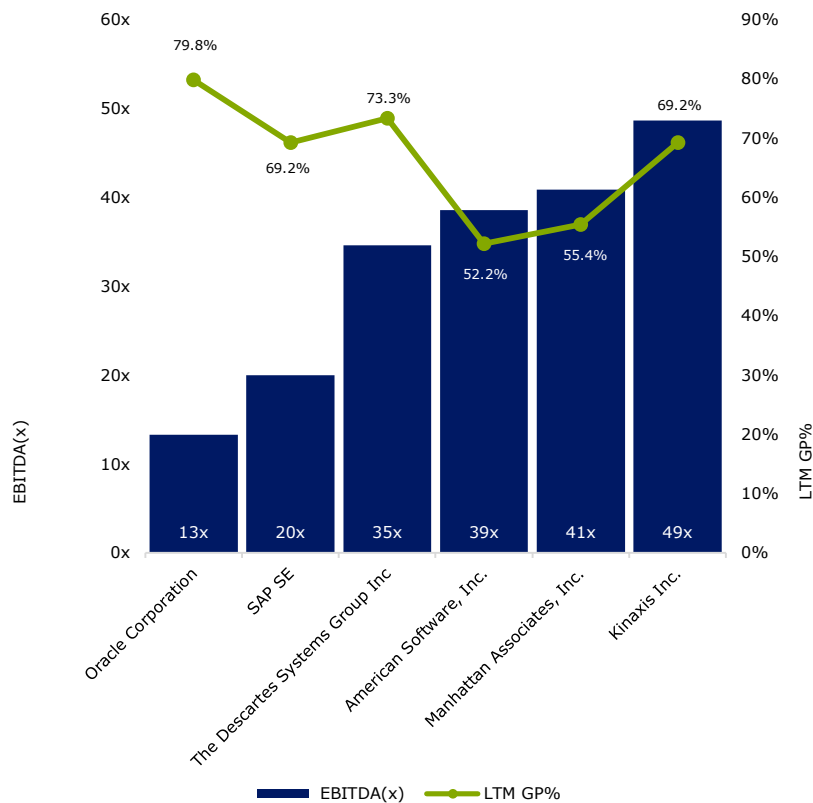

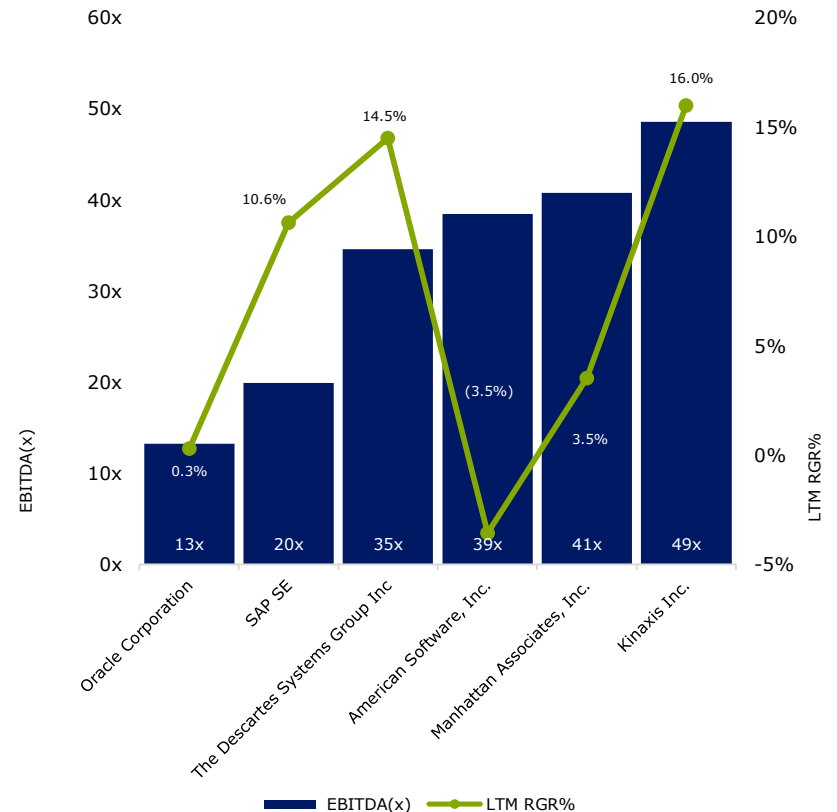

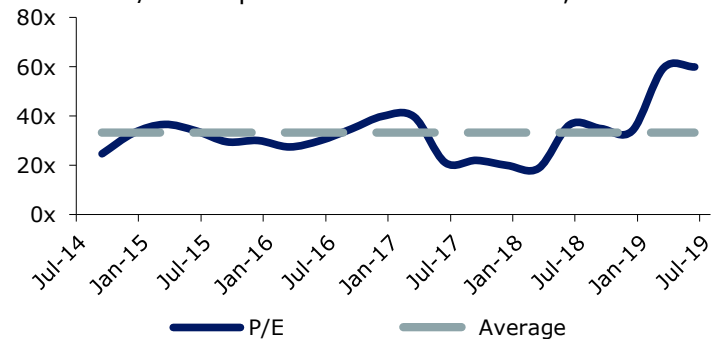
Revenue Multiples - American Software, Inc.

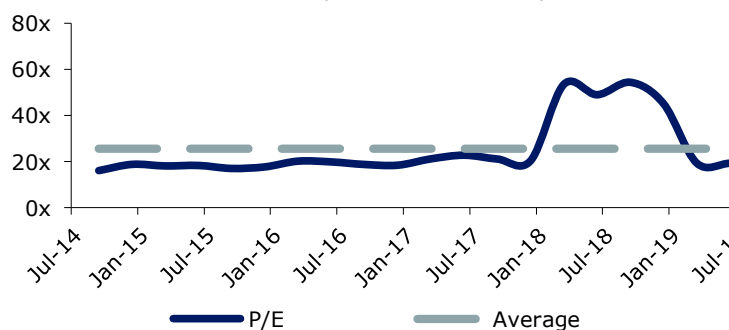
Revenue Multiples - Oracle Corporation
