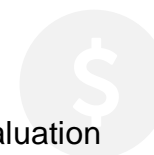

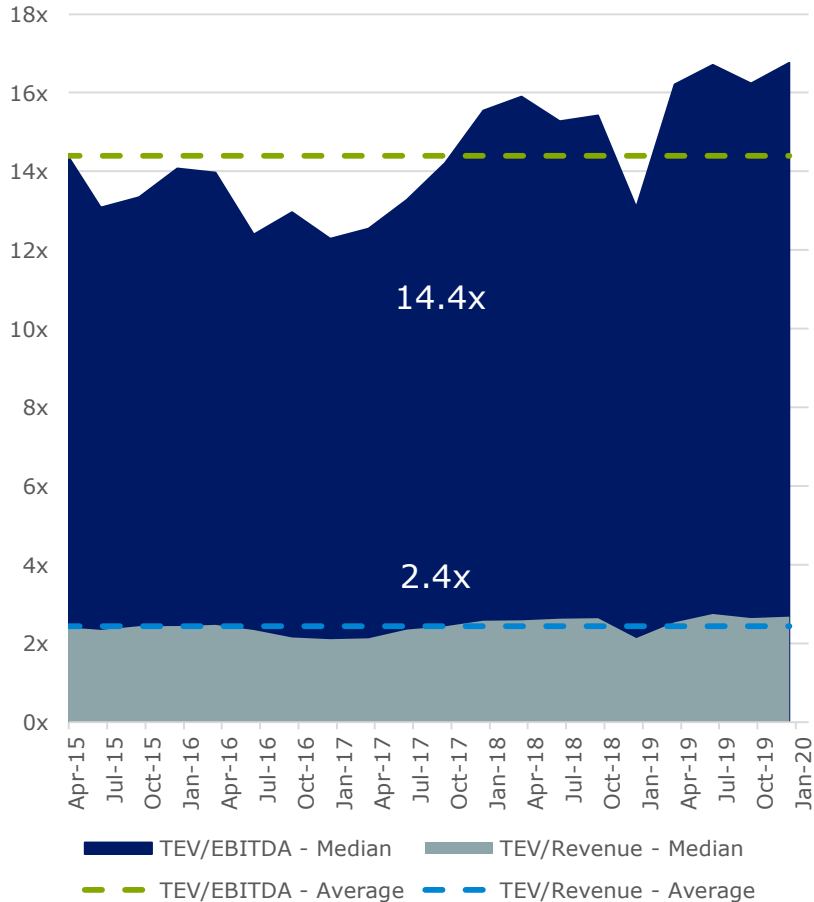

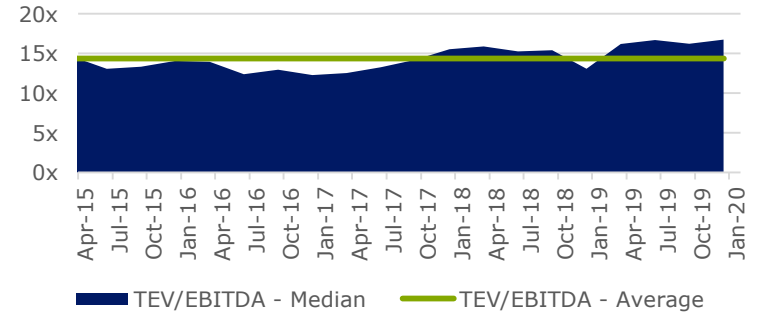

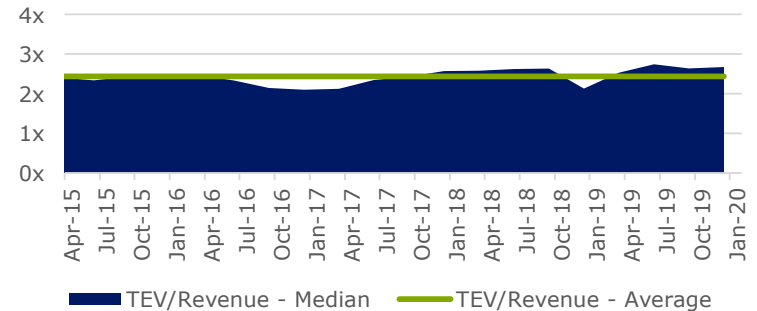

Public EBITDA Multiples over Time



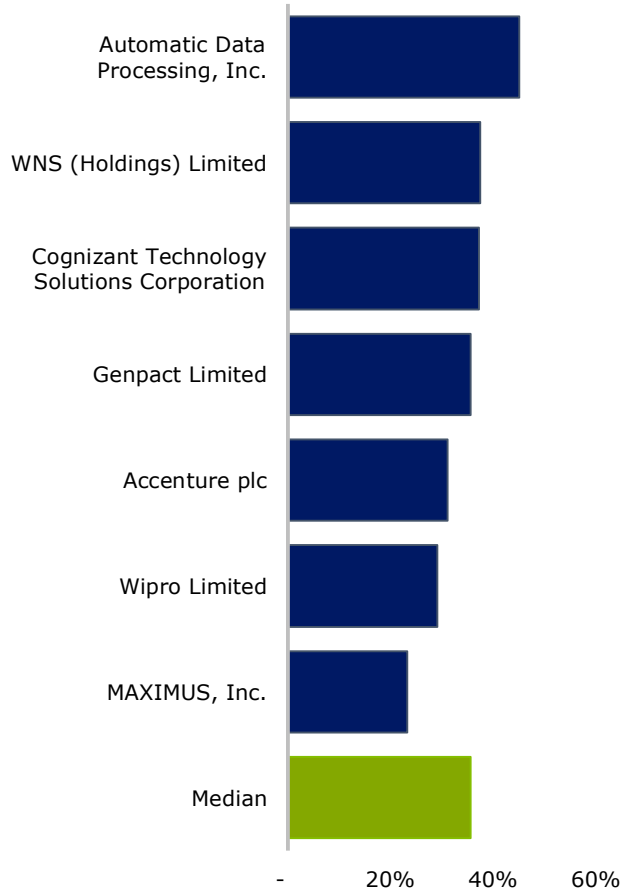
Public Revenue Multiples over Time

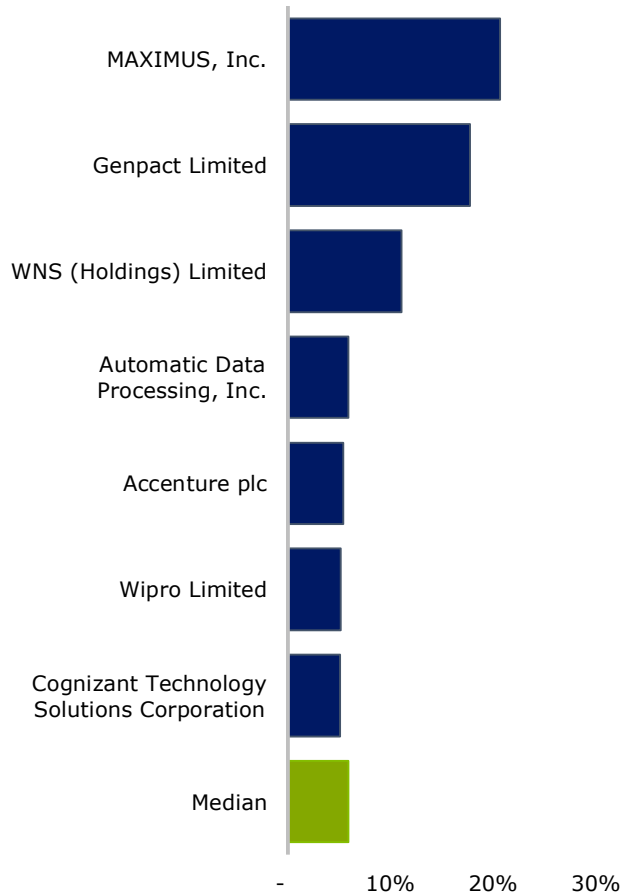

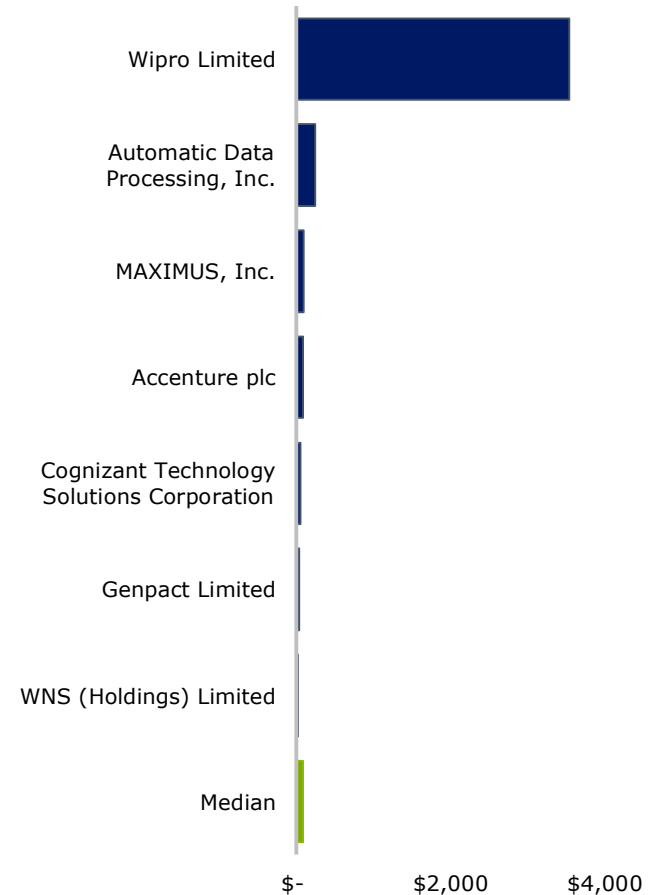

LTM Revenue Growth %



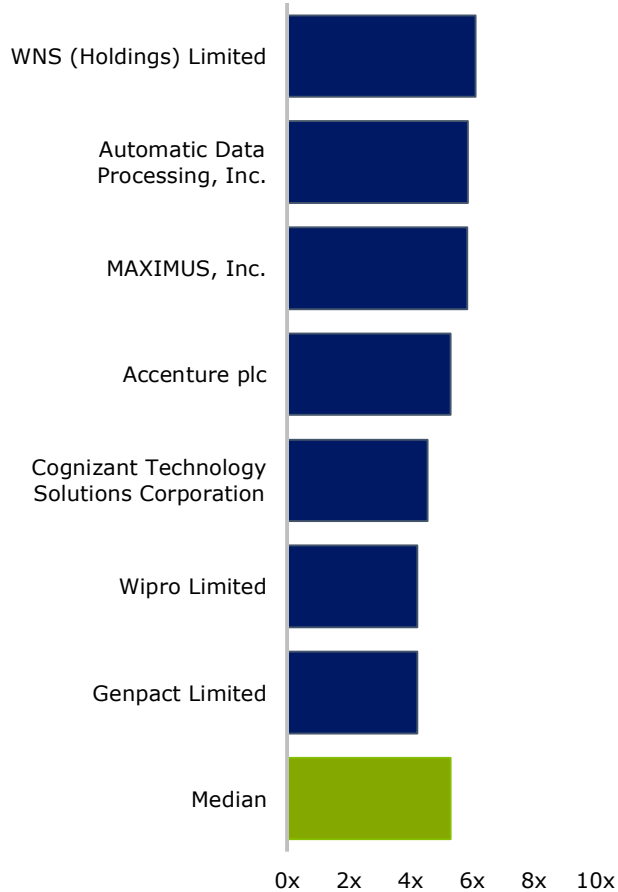

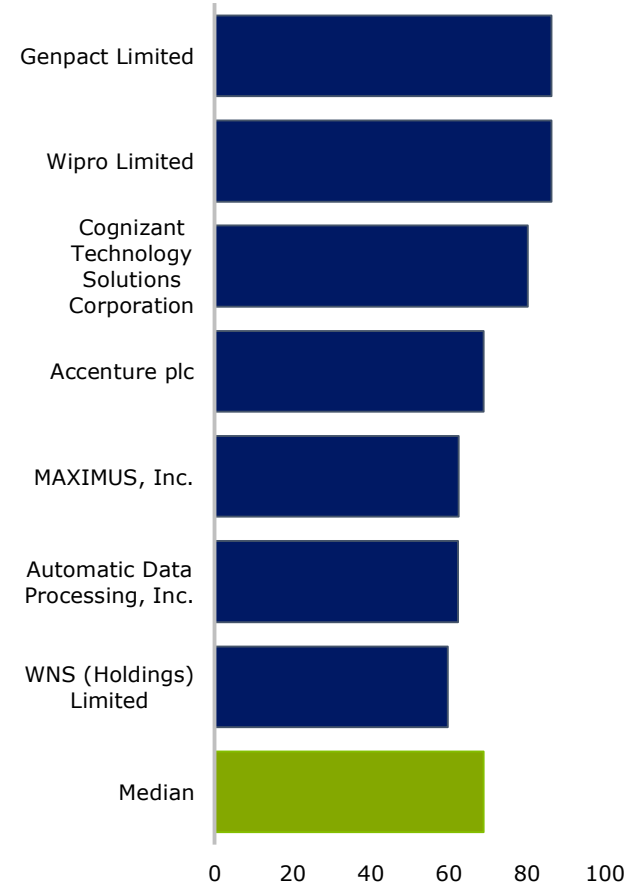

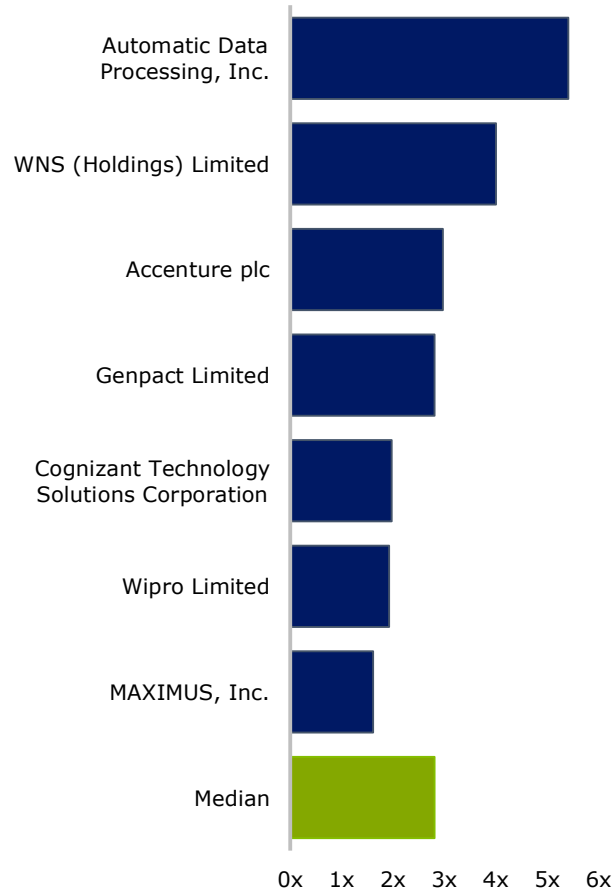

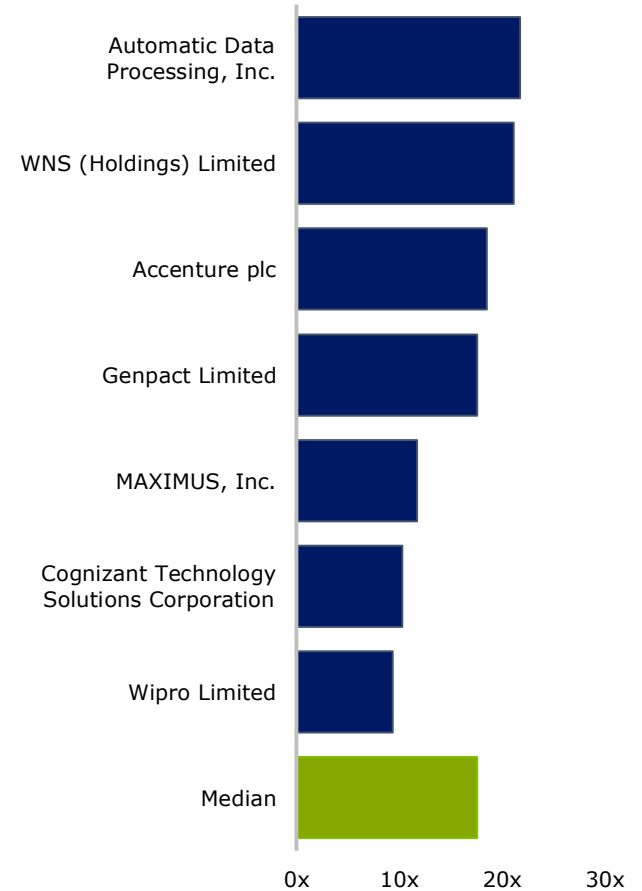

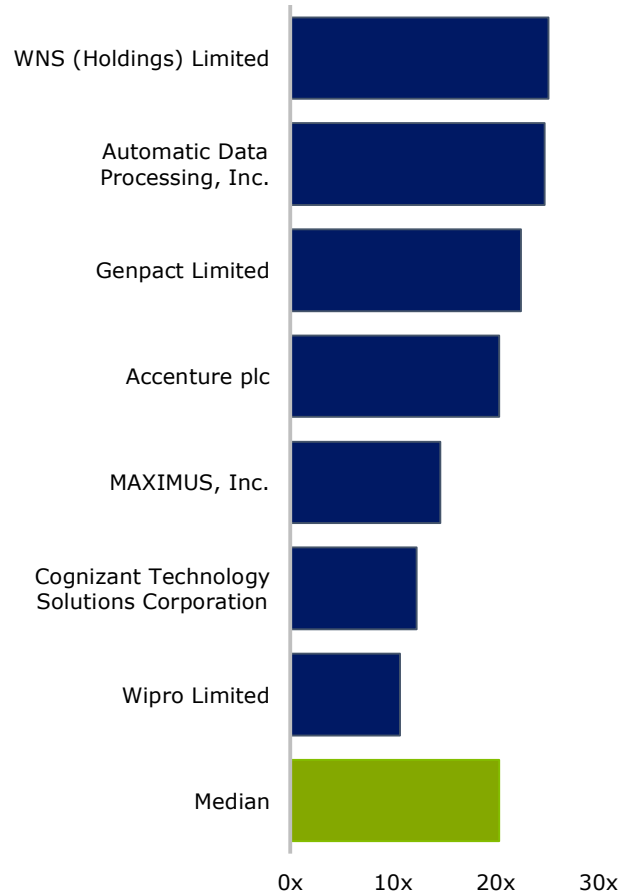

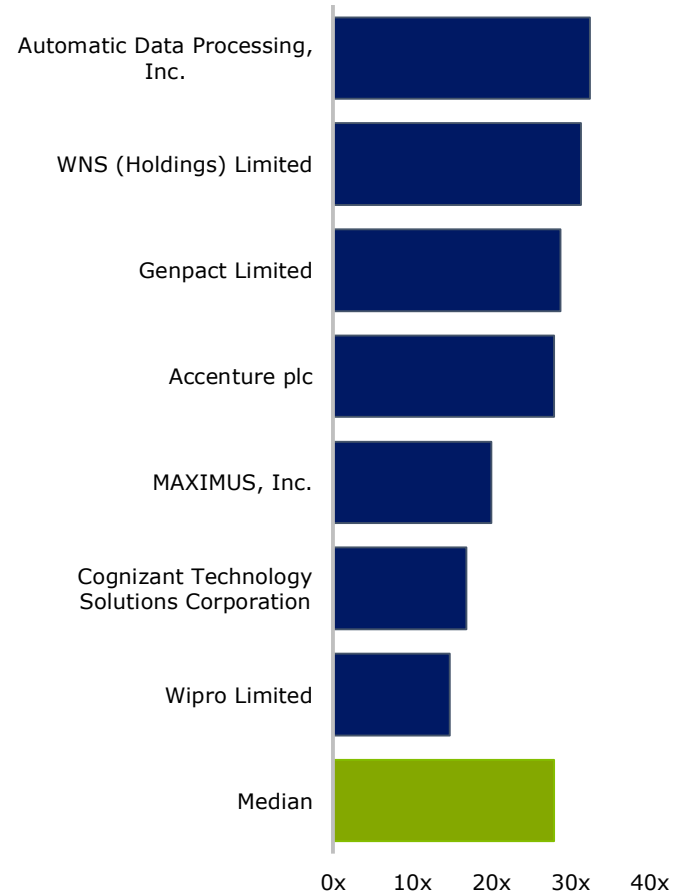

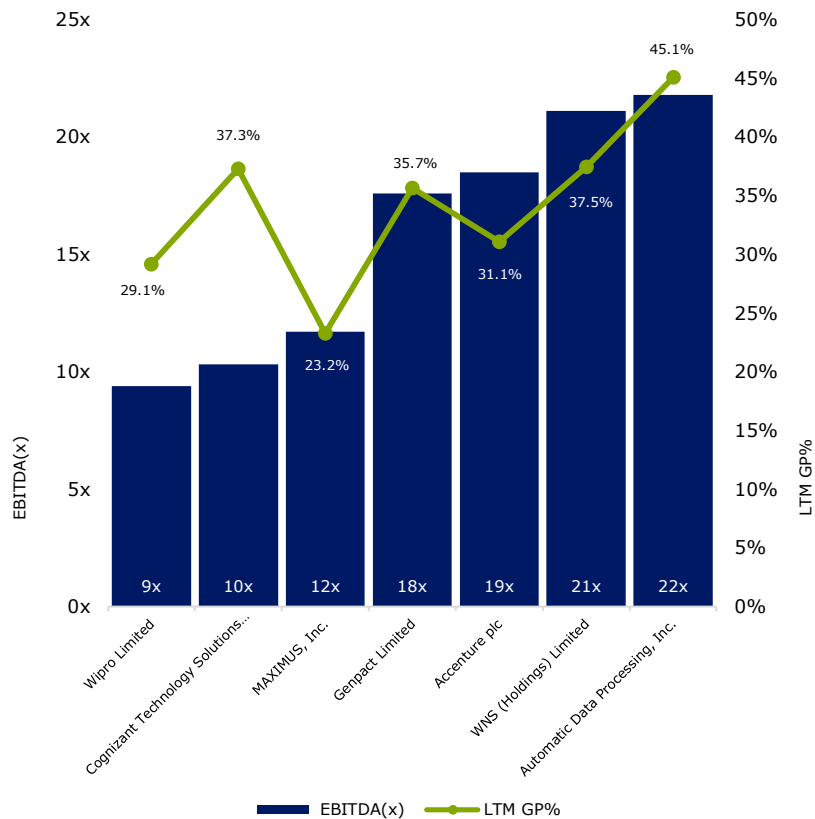

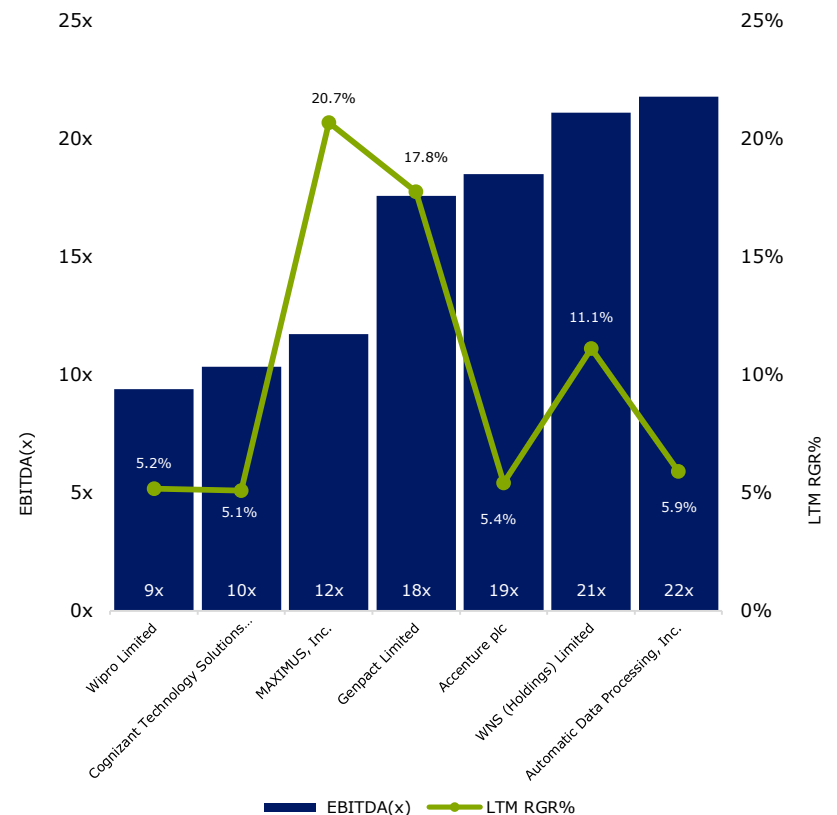
