




#### Public EBITDA Multiples over Time




#### Public Revenue Multiples over Time





#### LTM Gross Profit Margin %




#### LTM EBITDA %





#### LTM Revenue Growth %




### LTM Revenue per Full Time Employee x 000's










#### TEV / LTM EBITDA














#### EBITDA Multiples - Microsoft
